

## NORTON ROSE FULBRIGHT COMPETITION TERMS AND CONDITIONS

The competition is 'The Laws of the Game'. This competition is run in association with Harlequins Rugby Club. The entrants are required to submit a video (no more than 240 seconds) or a 300 word written submission answering the question: 'What do a premiership rugby team and a global law firm have in common?' The top five teams will be invited to the Final which will be held at the Norton Rose Fulbright London office on Friday February 22, 2019. The winning team will win a week of work experience at the Norton Rose Fulbright London office and an unforgettable experience day at the home of Harlequins Rugby Club, the Stoop.

Please read the terms and conditions carefully as certain eligibility criteria apply.

- 1 The competition organiser is Norton Rose Fulbright LLP of 3 More London Riverside, London, SE1 2AQ, United Kingdom. - 3 **How to enter:** The competition will run from 09:00 GMT on Monday October 1, 2018 and close at 17:00 GMT on Wednesday January 23, 2019. Entries received after this time will not be considered. - 5 **Judging:** The competition entries will be judged by members of the Norton Rose Fulbright Graduate Recruitment team including the Norton Rose Fulbright Graduate Recruitment partners and a representative from Harlequins Rugby Club based on academic rigour; creativity in terms of approach and arguments developed; high standard of written English; attention to detail; excellent legal analysis (demonstrating appropriate referencing and accreditation of sources if appropriate); and strength of argument in your entry We will be looking for the most apt and original answer that is well-researched, well written and creative. The organizer's decision is final in all matters connected with the competition.
- 6 **Winner Announcement and Claiming:** The winning teams will be contacted on Monday February 4, 2019 by email. In the event that the organiser does not have full and correct contact details, or is unable to contact you in relation to your entry, you may be automatically disqualified and the organiser reserves the right to offer the prize to the next eligible entrant. The winners' details may be published on social media channels (with permission).
- 7 **Data Protection:** You consent to the organiser using and processing your personal data for the purpose of publishing, promoting and sharing your entry to the competition including with third party suppliers insofar as is required to fulfil, deliver or arrange the prize (the **Contribution**).
